DISCLOSURE REQUIREMENTS - CUSTOMERS / BUSINESS PARTNERS

In accordance with Article 13(1) and (2) of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (hereinafter referred to as: GDPR) we hereby inform that:

- 1) Your Personal Data Controller (PDC) is: The President of the Management Board of Wojskowe Centralne Biuro Konstrukcyjno-Technologiczne S.A. (Central Military Bureau of Design & Technology)
- 2) Our contact details are the following: Wojskowe Centralne Biuro Konstrukcyjno-Technologiczne S.A., ul. Radiowa 13, 01-485 Warsaw.
- 3) You can contact the Data Protection Officer (DPO) by e-mail: IOD@wcbkt.pl or by sending a letter to the address of the Personal Data Controller (point 2).
- 4) Your personal data shall be processed pursuant to Article 6(1)(a)(b)(f) of GDPR, i.e. on the basis of consent, if you consent to the processing of your personal data, for the purposes indicated by PDC, to conclude and perform the contract to which the data subject is a party, and to take action at the request of the data subject, prior to entering into the contract, for the purposes arising from the legitimate interests pursued by PDC, the legitimate interest of PDC is marketing of its own products and pursuing claims arising from legal provisions.
- 5) The provision of personal data is voluntary, but necessary for entering into a contract. The provision of personal data for purposes indicated in the consent is voluntary.
- 6) The recipients of personal data may be the following: authorised public bodies; entities of the Polish Armaments Group (based on internal contracts), entities providing services in the field of contract performance and debt collection, entities delivering correspondence, entities providing archiving services and destruction of documentation, entities providing legal services, entities providing technical and technological services, entities providing IT services.
- 7) Personal data shall be processed for the period necessary to achieve the purposes of processing indicated in point 4. If you give your consent to the processing of personal data, such personal data shall be processed until the withdrawal of such consent, with regard to a contract performance, for the period until its termination, after that time the data shall be processed for the period required by law or for the period necessary to pursue claims, with regard to the fulfilment of legal obligations incumbent on PDC, the data shall be processed for the period of fulfilling these obligations, with regard to the fulfilment of legitimate

interests of ADO, the data shall be processed until the positive consideration of objection to personal data processing submitted by you.

8) If you provide personal information to PDC, please be advised of your right to:

- access your personal data and request a copy of your personal data,
- correct your personal data,
- restrict the processing of your personal data,
- transfer your personal data,
- erase your personal data if no other purpose of processing is implemented, e.g. processing based on consent.

In case of personal data processing on the basis of consent, you can additionally exercise the right to:

- transfer your personal data,
- withdraw your consent,
- erase your personal data if no other processing purpose is implemented, e.g. performance of the contract. In relation to data processed on the basis of legitimate interests pursued by PDC, you have the right to object to the processing of your personal data.

In case of personal data processing with the use of automated decision-making process and the use of data profiling you have the right to:

- withdraw your consent,
- transfer your personal data,
- object to the processing.

9) You can exercise your rights by sending a letter or e-mail to the DPO (points 2, 3). Please be informed that you have the right to lodge a complaint with the supervisory body - the President of the Personal Data Protection Office.
